ONE YEAR LIMITED WARRANTY

Bridgeport Fittings, Incorporated ("BFI") warrants to BFI's customer the product being sold to the customer as being free from manufacturing and material defects for the period of one (1) year from the date of delivery of the product to the customer. BFI shall have the right to replace or repair said product, at BFI's option, upon return of same by customer to BFI within said one (1) year period. This limited warranty shall not, however, apply where the product has been modified, damaged, not installed or used in a proper or legal manner or installed or used in a manner contrary to BFI's instructions. Customer shall be solely responsible to determine the suitability of the product for customer's intended use.

BFI SHALL HAVE NO LIABILITY TO CUSTOMER ON ANY BASIS FOR ANY CLAIMS OR DAMAGES HOWSOEVER ARISING UNDER OR RELATED TO THE PRODUCT, OTHER THAN THE SAID REPAIR OR REPLACEMENT OF THE PRODUCT, OR AT BFI'S FURTHER OPTION, TO REFUND TO BFI'S CUSTOMER THE AMOUNT PAID FOR SAID PRODUCT. TRADE Terms & Conditions of Sale

- 1. Shipments will be billed through authorized Bridgeport Fittings distributors.
- 2. Bridgeport Fittings cannot accept material for credit or exchange. Any requests for material of material must be made to the Bridgeport Fittings distributor from whom the material was originally purchased.
- **3.** The terms of shipment shall be F.O.B. shipping point. Additional charges for packaging or shipping may apply depending upon customer specifications.
- 4. Delivery and shipment dates are estimated dates only, and unless specified, are determined from the date of receipt of complete order and technical information as required. In estimating such dates, no allowance has been made nor shall we be liable directly or indirectly for delays of carriers or delays from labor difficulties, shortages, strikes or stoppages of any sort, fires, accidents, failure or delay in obtaining materials or manufacturing facilities, acts of government affecting us directly or indirectly, bad weather, or any causes beyond our control or causes designated Acts of God or force majeure by any court of law, and the estimated delivery date shall be extended accordingly.
