



## **POP-ON BUSHING**

## **INSTALLING INSTRUCTIONS**



- Cut conduit end squarely. Remove sharp edges and burrs from inside and outside diameters by reaming or filing. (See Fig. 1)
- Slip the POP-ON BUSHING over the end of the conduit to the end of the recess. (See Fig. 2)
- 3. Using the flat surface of any standard utility tool such as an electrician's pliers (or hammer with a block of wood for the larger sizes), strike the bushing on its top surface using a series of light blows until the end of the conduit rests against the bushing throat and conduit stop. (See Fig. 3)




